Masters Tournament RULES

All the games bowled in the Passaic County USBC Masters Tournament are subject to the current rules of the United States Bowling Congress (USBC) unless waived, amended, and/or listed below. The tournament manager reserves all rights to cancel or reschedule the event for any reason he deems fit.

ELIGIBILITY - A bowler must be a sanctioned USBC member of the Passaic County USBC and hold a current USBC Card. Proof of eligibility will be asked for at the time of check-in. Affiliate membership may be purchased at the tournament site.

FORMAT – This is a **One Day** event to determine the Passaic County USBC Masters Champion. This is an individual scratch event, open to all bowlers who wish to participate. The tournament will consist of a five (5) game qualifying round with each game being bowled on a different pair of lanes. If the total entry count is 15 bowlers or less, the top three bowlers will advance to a step-ladder final at this point. The matches will be two games, and the total wood of those two games determines the winner.

If the paid entry count is more than 15 bowlers, the field will then be cut to the top 40% of the field. The exact number might be adjusted upward slightly to facilitate an equal number of bowlers on each pair for the second qualifying round of three (3) additional games. All pin fall will be brought forward. The top four will then advance to a step-ladder final at this point. The matches will be two games, and the total wood of those two games determines the winner.

ENTRY RULE: REPORTING PRIOR PRIZE WINNINGS – USBC Rule 319d is waived for this event.

PRIZE RATIO – shall be at least 1 for every 5 paid entries. The prize money portion of the entry will be returned 100%. The qualifying leader after the first five (5) games will receive a cash prize if the entry count is 25 or higher. The winner of this tournament will receive a cash prize (based upon paid entry), and a trophy. All cashing bowlers will be paid on the spot at the end of the tournament! The previous year's champion will receive a free entry into the following year's tournament.

ENTRIES – Walk-in entries are welcome, and the entrance fee must be paid for in **CASH**. All walk-in entrants are asked to check-in a minimum of 15 minutes prior to the start of this event. Entries will close for this event at 9:20 AM on November 20, 2016.

CONDITIONS – You will be bowling on a “*Competitive Shot or Condition*” **not** the typical house shot.
